4-H Camp Palmer reserves the right to deny an application and refund the sponsor fee. This application will only be considered accepted when the brick is installed.

The sponsor fee includes a standard font with 8 lines per brick with 19 characters per line, including spaces and punctuation. Standard, simple clipart can get inserted at no charge (ex: Tree, dog, pig, leaf, 4H clover, etc). Clipart will reduce lines/spaces per brick.

4-H Camp Palmer does not make any guarantees about where a brick will be placed. Should it become necessary, the brick can be relocated at any time with no liability to the sponsor.

Sponsor agrees that the brick may be permanently removed. If the brick is permanently removed prior to its tenth anniversary of its installation, Sponsors only right shall be to receive a prorated refund of sponsorship fee. If the brick is removed after the tenth anniversary of its installation, sponsor shall not have any right to refund/compensation or any other remedy.

Sponsor shall have no control over format, construction, installation or maintenance of the brick. Sponsor shall have input to the message on the brick with final approval by 4-H Camp Palmer. Sponsor will not have the right to require that the brick be maintained, repaired, replaced, removed or relocated.

Neither this agreement or the installation of the brick entitles Sponsor to any right, title or interest in any property or real estate; or free services at 4-H Camp Palmer.

Sponsor shall acquire no right under this agreement to use the name 4-H Camp Palmer to express or imply affiliation, approval or endorsement.

Sponsor only right or remedy as a result of any breach of 4-H Camp Palmer’s obligations under this agreement shall be to receive a prorated refund of the sponsorship fee.
